- Twilight Road has been reshaped and regraded.
- Front Tires on the backhoe went out and were fixed.
- Water has been completely turned off except the bath houses at the park office.
- Checked the SD cards from the trail cameras. There are a lot of Coyotes pictured.

Sam Short made a motion for Mark or Mason to be able to take measures to protect themselves when working on the back forty. Phil Clifton seconded the motion. Motion was Carried with a unanimous vote.

- Received information on a filter for the water plant which includes a back flusher.
- Received an estimate to replace the well in spring. Estimated was from Warthman Drilling for \$10,580.00. Estimate is to be reevaluated before the spring.
- Fence for Pool Will be tearing up all concrete and fence for construction on new pool. Discussion was made on making the decking wider. Extend about 12 foot. New stone wall is to be installed and extension of decking to butted up to the wall. Old wall will be demolished before pool concrete can be poured.
- Pool Pump House will be a 10 X 10 structure to allow enough room to be able to repair the pump if needed.
- Hazel is calling the Pool man to go over details of the contract.
- Calling for prices for new pool pump house.
- Pain is peeling on the wall in bath house #5
- Lots 368, 327, 405, 406 and 407 are to be marked. Mark will ensure that all these lots have location markers
- Shower in Comfort Station #2 as been taken care of.
